2. Processed Personal Data and Purposes

In the context of the online MS seminars, your eMail address, name and interests will be processed for the following purposes:

For an email distribution list with disclosed recipients

for the communication of new seminar dates and topics

For personal contact

- in the event that you indicated an interest in being a speaker during the registration
- for the arrangement of the presentation topic and date

For tailoring the presentation topics.

Legal Basis

The collection of personal data for the aforementioned purpose of communicating new seminar dates and topics, and for arranging presentation topics and dates, is based on the consent of the data subjects, in accordance with Article 6(1)(a) of the GDPR.

3. Data Transfer

We do not transmit your personal data, which is processed by the University of Wuppertal for the purposes mentioned in point 2, to third parties.

If technical service providers gain access to personal data, this occurs on the basis of a contract in accordance with Article 28 of the GDPR.

4. Duration of processing/ Data Erasure

Data that is processed for the purposes mentioned under point 2 will be deleted immediately upon receipt of your revocation. Your data will also be automatically deleted in case Online MS Seminars is no longer pursued. The deletion will be confirmed via email.

5. Your Rigths

As a data subject, you can assert at any time the rights granted to you by the GDPR:

- the right to obtain information about whether and which personal data concerning you are being processed (Art. 15 GDPR).
- the right to request the correction or completion of personal data concerning you (Art. 16 GDPR),
- the right to erasure of personal data concerning you in accordance with Art. 17 GDPR,
- the right to request a restriction of the processing of your personal data in accordance with Article 18 GDPR,
- the right to withdraw an given consent at any time. The lawfulness of processing carried out on the basis of the consent until revocation is not affected by this (Art. 7 Abs. 3 GDPR).
- the right to lodge a complaint with a supervisory authority for data protection (Article 77 GDPR),
